2. Unpaid 2020/2021 Village Taxes After explanation by Superintendent Melock, motion was made by Trustee Skelton, seconded by Trustee Pazzuti; carried, Mayor Krebs, Trustees Skelton, Pazzuti, Braman and Wikman voting yes, none opposed to relieving the unpaid 2020/2021 Village of Springville taxes to Erie County as per the attached list. **111620 A.1**

3. 37 S. Central Demo Bid Award After extensive discussion by all attending, motion was made by Trustee Wikman, seconded by Trustee Pazzuti; carried, Mayor Krebs, Trustees Wikman, Pazzuti, Braman and Skelton voting yes, none opposed to award the bid for demolition of 37 South Central Ave. to Metro Contracting & Environmental Inc., 2939 Lockport Rd., Niagara Falls, NY in the amount of \$22,175 per the bid opened on November 5, 2020.
4. This is for services provided by the Erie County Legislature VAP Community Resource Team.

Arts Services Initiative Grant App Motion made by Trustee Braman, seconded by Trustee Wikman; carried, Mayor Krebs, Trustees Braman, Wikman, Pazzuti and Skelton voting yes, none opposed to authorizing the Arts Services Initiative Grant application along with any agreements and signature for the \$10,000 grant Application for 2021 Thursdays Downtown Concert Series expenses. There is a 50% match for the village of \$5,000 with the grant award being \$5,000. The application is for outdoor speakers and music acts.
